MEETING OF THE PROCUREMENT COMMITTEE

A meeting of the Procurement committee was held on 24-02-2025 under the chairmanship of Additional Secretary (Admn). All committee members participated in the meeting.

2. The Chair welcomed the participants and invited Deputy Director – IT to apprise the committee on the progress made so far.

3. The Deputy Director – IT informed that a total of 10 bidders participated in the bid. The received 10 bids were checked against the eligibility criteria set forth in the bidding documents. Out of 10 bidders, 4 bids (M/s Micros System, Jam Sons, Silicon Technologies and Endless Suppliers) have been declared in-eligible owing to deficiency of not producing SECP/Form-H registration as per standard bidding documents. The eligibility checklist is attached at **Annex-I**.

4. The remaining 6 bids financials and conformity with specifications as mentioned in the standard bidding documents were checked. Based on fulfillment of required specifications and lowest bid the following recommendations are made for award (Comparative Statement at **Annex-II**):

- a. M/s Paragon Office Solution for Desktop Computers
- b. M/s Premier Suppliers Pvt Ltd for UPS for Desktop Computers
- c. M/s Premier Suppliers Pvt Ltd for UPS for Laptops
- d. M/s Premier Suppliers Pvt Ltd for UPS for Printer (Normal)
- e. M/s Aursoft Pvt Ltd for Printer (Heavy)
- f. M/s Premier Suppliers Pvt Ltd for Video Conference System (Camera)

5. The committee decided to share/upload both eligibility checklist and comparative statement to KPPRA website for information of all concerned.

6. The committee further decided that an inspection committee should be constituted to re-verify the conformity of delivered items as per standard bidding documents.


