**Distribution of seats for D.COM / DBA Program:-**

**Note:-**

- Seats falling vacant under any quota (except Afghan quota) shall be allocated to jurisdiction local OR vacant seats can be transferred from any quota to another quota as per need.
- Afghan refugees shall submit their application for admission through proper channel.

**Distribution of seats for Associate Degree Program / BS Program/ BBA:-**

Note: For ADP 1st semester, a minimum enrollment must be at least 50% of allocated seats

**Note:-**

In case of admission to the ADP, the seat distribution of each subject combination offered shall be on similar analogy of BS program. However, admission to 5<sup>th</sup> semester shall be offered only on those seats which have been leftover due to drop out students for any reason in the respective BS program and students fulfilling

criteria can apply for new intake. However, the merit list will be prepared according to percentage. Eligibility criteria of the respective affiliating university shall be followed for such candidates
