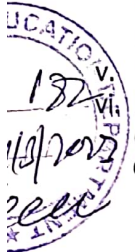
NOTIFICATION

NO.SO(C-III)/HED/1-1/Rect/Urdu: In pursuance of recommendations of Khyber Pakhtunkhwa Public Service Commission read with para 4(d) of the Election Commission of Pakistan notification No.F.2(1)/2023-Cord dated 22.01.2023, the Chief Minister, Khyber Pakhtunkhwa being competent authority under Rule-4(1)(a) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 is pleased to appoint **Ms. Razia Bibi** D/O Maroof Jan (Domicile/Zone; Lakki Marwat /4) as **Associate Professor (BPS-19)** in the subject of **Urdu** in Higher Education Department.

2. Posting/transfer order of the Associate Professor concerned will be issued, later on.
3. The appointment of the above Associate Professor will be subject to the following terms and conditions:-

TERMS AND CONDITIONS:

- i. She will have all rights / privileges contained in the Khyber Pakhtunkhwa Civil Servants Act, 1973 with all amendments therein and the rules made thereunder.
- ii. The appointee is required to join her post within **thirty (30) days** of the issuance of this Notification, failing which it shall be presumed that she is not interested to join the same. The Director, Higher Education Khyber Pakhtunkhwa, Peshawar shall furnish a certificate to the effect that the appointee has joined the post or otherwise, after one month of the issuance of this Notification.
- iii. In case of disciplinary matters, Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 shall be applicable.
- iv. She will be on probation for a period of **one (01) year** extendable for another year by specific order of the Competent Authority within two months of the expiry of first year of probation period, under Rule-15, amended on 07.12.2017 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989. She will get pay of BS-19 including usual allowances as admissible under the rules. In case of resignation, the officer will have to give one month's prior notice. In case of absence of such notice, her one month's pay / allowance will be forfeited to Government.
