**No.SO(CE&MS)HED/1-35/2023** Consequent upon the recommendations of Khyber Pakhtunkhwa Public Service Commission, the Chief Minister Khyber Pakhtunkhwa, being Competent Authority in respect of officers in BPS-18 under Rule-4(1)(a) of the Khyber Pakhtunkhwa, Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 is pleased to appoint Muhammad Anwar S/O Fazal Ghani (Domicile/Zone, FR Bannu/1) as Assistant Professor (BPS-18), in the subject of English in Directorate General of Commerce Education and Management Sciences, Khyber Pakhtunkhwa, with immediate effect:-

The appointment of the above Assistant Professor (BPS-18) will be subject to the following terms and conditions:-

**TERMS AND CONDITIONS:**

- i. He will have all rights / privileges contained in the Khyber Pakhtunkhwa Civil Servants Act, 1973 with all amendments therein including Khyber Pakhtunkhwa Civil Servants (Amendment) Act, 2013 and the rules made thereunder.
- ii. The appointee is required to join his post within **thirty (30) days** of the issuance of placement Notification to be issued in pursuance of this Notification, failing which it shall be presumed that he is not interested to join the same. The Directorate General of Commerce Education and Management Sciences, Khyber Pakhtunkhwa, Peshawar shall furnish a certificate to the effect that the appointee has joined the post or otherwise, after one month of the issuance of this Notification.
- iii. In case of disciplinary matters, Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 shall be applicable.
- iv. He will be on probation for a period of one (01) year extendable for another year by specific order of the Competent Authority within two months of the expiry of first year of probation period, under Rule-15, amended on 07.12.2017 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- v. He will get pay of BS-18 including usual allowances as admissible under the rules.
- vi. In case of resignation, the officer will have to give one month's prior notice. In case of absence of such notice, their one month's pay / allowance will be forfeited to Government.
