

INVITATION FOR BIDS

2. Bidding shall be conducted through Single Stage-two Envelopes Bidding Procedure as per KPPRA Rules-2014.

The bids shall be opened on the same day by the Procurement committee in the presence of Representatives of the bidders who chose to attend at **13/03/2026 12:30 PM** in the Committee room of Higher Education Department Civil Secretariat Peshawar Khyber Pakhtunkhwa. Bid submitted after due date & time shall not be entertained.
5. The bid must be accompanied by Bid Security @ 2% of the total quoted bid value in shape of CDR in the name of the undersigned.
6. Rates shall be quoted in Pak Rupees and on FOR basis inclusive of all taxes where applicable and valid up to 30th June 2026.
7. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in schedule-II of the Act (ibid).
8. The bid must be valid up to 120 days from date of opening of the bid.
