- 3. The appointment of the above Lecturers will be subject to the following terms and conditions:-

TERMS AND CONDITIONS:

- They will have all rights / privileges contained in the Khyber Pakhtunkhwa Civil Servants Act, 1973 with all amendments therein and the rules made thereunder.
- ii. The appointees are required to join their posts within thirty (30) days of the issuance of this Notification, failing which it shall be presumed that they are not interested to join the same. The Director, Higher Education Khyber Pakhtunkhwa, Peshawar shall furnish a certificate to the effect that the appointees have joined the posts or otherwise, after one month of the issuance of this Notification.



- iii. In case of disciplinary matters, Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules. 2011 shall be applicable.
- iv. They will be on probation for a period of one (01' year extendable for another year by specific order of the Competent Authorizy within two months of the expiry of first year of probation period, under Rule 15, amended an 0.7.12.2011 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- v. They will get pay of BS-17 including usual allowances as admissible under the rules.
- vi. In case of resignation, the officers will have to give one month's prior notice in case of absence of such notice, their one month's pay / allowance will be forfeited to Government.
