NO.SO(C-II)/HED/11-2/2023/AP Zoology: (in pursuance of recommendations of Khyber Pakhtunkhwa Public Service Commission read with para 4(d) of the Election Commission of Pakistan notification No.F.2(1)/2023-Cord dated 22.01.2023, the Chief Minister Khyber Pakhtunkhwa, being competent authority in respect of officers in BS-18 and above under Rule-4(1)(a) of the Khyber Pakhtunkhwa, Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 is pleased to appoint the following Assistant Professors (BS-18) in the subject of Zoology in Higher Education Department, with immediate effect:-

The appointment of the above Assistant Professors will be subject to the following terms and conditions:-

TERMS AND CONDITIONS:

i. They will have all rights / privileges contained in the Khyber Pakhtunkhwa Civil Servants Act, 1973 with all amendments therein and the rules made thereunder.

ii. The appointees are required to join their posts within thirty (30) days of issuance of placement notification to be issued in pursuance of this Notification, failing which it shall be presumed that they are not interested to join the same. The Director, Higher Education Khyber Pakhtunkhwa, Peshawar shall furnish a certificate to the effect that the appointees have joined the posts or otherwise, after one month of the issuance of placement Notification.

iii. In case of disciplinary matters, Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 shall be applicable.

- iv. They will be on probation for a period of one (01) year extendable for another year by specific order of the Competent Authority within two months of the expiry of first year of probation period, under Rule-15, amended on 07.12.2017 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- v. They will get pay of BS-18 including usual allowances as admissible under the rules.
- vi. In case of resignation, the officers will have to give one month's prior notice. In case of absence of such notice, their one month's pay / allowance will be forfeited to Government.
