TERMS AND CONDITIONS:

The Directorate General of Commerce Education and Management Sciences, Khyber Pakhtunkhwa, Peshawar-shall furnish a certificate to the effect that the appointees have joined the posts or otherwise, after one month of the issuance of this Notification.
