No.SO(CE&MS)HED/1-35/2023 Consequent upon the recommendations of Khyber Pakhtunkhwa Public Service Commission, the Chief Secretary Khyber Pakhtunkhwa, being competent authority in respect of officers in BPS-17 under Rule-4(1)(b) of the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Appointment, Promotion and Transfer) Rules, 1989 is pleased to appoint the following Male Lecturer in Computer Science (BPS-17), in Government Colleges of Commerce/Management Sciences with immediate effect:-

3. The appointment of the above Lecturer (BPS-17) will be subject to the following terms and conditions:-

TERMS AND CONDITIONS:

- i. He will have all rights / privileges contained in the Khyber Pakhtunkhwa Civil Servants Act, 1973 with all amendments therein and the rules made thereunder.
- ii. The appointee is required to join their post within **thirty (30) days** of the issuance of this Notification, failing which it shall be presumed that he is not interested to join the post. The Director General of Commerce Education and Management Sciences, Khyber Pakhtunkhwa, Peshawar shall furnish a certificate to the effect that the appointee has joined the post or not after one month of the issuance of this Notification.
- iii. In case of disciplinary matters, Khyber Pakhtunkhwa Civil Servants Act, 1973 and the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 shall be applicable.
- iv. He will be on probation for a period of one (01) year extendable for another year by special order of the Competent Authority within two months of the expiry of first year of probation under Rule-15, amended on 07.12.2017 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- v. He will get pay of BS-17 including usual allowances as admissible under the rules.
- vi. In case of resignation, the officer will have to give one month's prior notice. In case of absence of such notice, their one month's pay / allowance will be forfeited to Government.
