NOTIFICATION

Consequent upon the recommendations of NO.SO(C-II)/HED/11-1/2023/Urdu/ Khyber Pakhtunkhwa Public Service Commission, the Chief Secretary Khyber Pakhtunkhwa, being competent authority in respect of officers in BPS-17 under Rule-4(1)(b) of the Khyber Pakhtunkhwa, Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 is pleased to appoint Mr. Waqar Ahmad S/O Akhtar Muhammad District Bannu (Zone/4) as Lecturer (BS-17) in the subject of Urdu in Higher Education Department, with immediate effect:-

- Posting/transfer order of the Lecturer concerned will be issued, later on. 2.
- The appointment of the above Lecturer will be subject to the following 3. terms and conditions:-

TERMS AND CONDITIONS:

- i. He will have all rights / privileges contained in the Khyber Pakhtunkhya Civil Servants Act, 1973 with all amendments therein and the rules made thereunder.
- ii. The appointee is required to join his posts within thirty (30) days of the issuance of placement notification to be issued in pursuance of this Notification, failing which it shall be presumed that he is not interested to join the same. The Director, Higher Education Khyber Pakhtunkhwa, Peshawar shall furnish a certificate to the effect that the appointee has joined the post or otherwise, after one month of the issuance of placement notification to be issued in pursuance of this Notification.

iii. In case of disciplinary matters, Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011

shall be applicable.

- iv. He will be on probation for a period of one (01) year extendable for another year by specific order of the Competent Authority within two months of the expiry of first year of probation period, under Rule-15, amended on 07.12.2017 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- v. He will get pay of BS-17 including usual allowances as dmissible under the rules.
- vi. In case of resignation, the officer will have to give one nonth's prior notice. In case of absence of such notice, their one month's pay ha owance will be forfeited to Government.
