The appointment of the above Associate Professor will be subject to the following terms and conditions:-

TERMS AND CONDITIONS:

- i. He will have all rights / privileges contained in the Khyber Pakhtunkhwa Servants Act, 1973 with all amendments therein and the rules made thereund
- ii. The appointee are required to join his post within thirty (30) days of the issue of this Notification, failing which it shall be presumed that he is not interested join the same. The Director, Higher Education Khyber Pakhtunkhwa, Peshawar furnish a certificate to the effect that the appointee has joined the post and otherwise, after one month of the issuance of this Notification.
- iii. In case of disciplinary matters, Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 shall be applicable.
- iv. He will be on probation for a period of one (01) year extendable for another weak by specific order of the Competent Authority within two months of the expiry of these year of probation period, under Rule-15, amended on 07.12.2017 of the Khyder Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989
- v. He will get pay of BS-19 including usual allowances as admissible under the re-
- vi. In case of resignation, the officer will have to give one month's prior notice. In case of absence of such notice, their one month's pay / allowance will be forfeited to Government.
