NO.SO(C-III)/HED/1-1/2023/Madeeha Habib/Psychology: /In pursuance of the recommendations of Khyber Pakhtunkhwa Public Service Commission read with para 4(d) of the Election Commission of Pakistan notification No.F.2(1)/2023-Cord dated 22.01.2023, the Chief Secretary Khyber Pakhtunkhwa, being competent authority in respect of officers in BPS-17 under Rule-4(1)(b) of the Khyber Pakhtunkhwa, Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, has been pleased to appoint Ms. Madeeha Habib D/O Habib Ullah Khan District Mohmand (Zone-1) as Lecturer (BPS-17) in the subject of Psychology in Higher Education Department.

- 2. Posting/transfer order of the Lecturer concerned will be issued, later on.
- 3. The appointment of the above Lecturer will be subject to the following terms and conditions:-

TERMS AND CONDITIONS:

- i. She will have all rights / privileges contained in the Khyber Pakhtunkhwa Civil Servants Act, 1973 with all amendments therein and the rules made thereunder.
- ii. The appointee is required to join her post within thirty (30) days of the issuance of this Notification, failing which it shall be presumed that she is not interested to join the same. The Director, Higher Education Khyber Pakhtunkhwa, Peshawar shall furnish a certificate to the effect that the appointee has joined the post or otherwise, after one month of the issuance of this No!ification.
- iii. In case of disciplinary matters, Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 shall be applicable.
- iv. She will be on probation for a period of one (01) year extendable for another year by specific order of the Competent Authority within tw. months of the expiry of first year of probation period, under Rule-15, amended on 07.12.2017 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- v. She will get pay of BS-17 including usual allowances at admissible under the rules.
- vi. In case of resignation, the officer will have to give one month's prior notice. In case of absence of such notice, her one month's pay / allowance will be forfeited to Government.
