Consequent upon the recommendations of Khyber Pakhtunkhwa Public Service Commission, the Chief Secretary Khyber Pakhtunkhwa, being competent authority in respect of officers in BPS-17 under Rule-4(1)(b) of the Khyber Pakhtunkhwa, Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 is pleased to appoint the following **Lecturers (BS-17)** in the subject of **Electronics** in Higher Education Department, with immediate effect:-

3. The appointment of the above Lecturers will be subject to the following terms and conditions:-

TERMS AND CONDITIONS:

- i. They will have all rights / privileges contained in the Khyber Pakhtunkhwa Civil Servants Act, 1973 with all amendments therein and the rules made thereunder.
- ii. The appointees are required to join their posts within **thirty (30) days** of the issuance of this Notification, failing which it shall be presumed that they are not interested to join the same. The Director, Higher Education Khyber Pakhtunkhwa, Peshawar shall furnish a certificate to the effect that the appointees have joined the posts or otherwise, after one month of the issuance of this Notification.
- iii. In case of disciplinary matters, Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 shall be applicable.
- iv. They will be on probation for a period of one (01) year extendable for another year by specific order of the Competent Authority within two months of the expiry of first year of probation period, under Rule-15, amended on 07.12.2017 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- v. They will get pay of BS-17 including usual allowances as admissible under the rules.
- vi. In case of resignation, the officers will have to give one month's prior notice. In case of absence of such notice, their one month's pay / allowance will be forfeited to Government.
