**No.SO(C-II)/HED/12-1/2021/Roohullah.** WHEREAS Mr. Roohullah, Lecturer in Chemistry (BS-17), Govt. Degree College Sam, South Waziristan was proceeded against under the Khyber Pakhtunkhwa Govt. Servants (Efficiency & Discipline) Rules, 2011.

2. **AND WHEREAS** the Chief Secretary, Khyber Pakhtunkhwa being competent authority appointed Mr. Nasir Ali, (PMS BS-18), Deputy Secretary, Irrigation Department as Inquiry Officer to conduct inquiry against the accused officer for the charges leveled against him in accordance with the Law/Rules.

3. **AND WHEREAS** the Inquiry Officer after having examined the charges, evidence on record and explanation of the accused officer, submitted report whereby the charges leveled against the accused officer stood proved.

4. **AND WHEREAS** the Chief Secretary, Khyber Pakhtunkhwa being competent authority served the accused officer with Show Cause Notice, tentatively imposed major penalty of "removal from service" on him.

5. **AND WHEREAS** the Competent Authority, upon receipt of the reply to show cause notice submitted by the accused officer, under Rule-15 of the Rules ibid, appointed Chief Staff Officer to Chief Secretary, Khyber Pakhtunkhwa to afford him opportunity of personal hearing on his behalf.

6. **NOW THEREFORE**, the Chief Secretary, Khyber Pakhtunkhwa being competent authority after having considered the charges, evidence on record, the explanation of the accused officer and in exercise of powers under Rule 14(5) of the Khyber Pakhtunkhwa Govt. Servants (Efficiency & Discipline) Rules, 2011 is pleased to impose the major penalty of "**Removal from Service**" on Mr. Roohullah, Lecturer in Chemistry (BS-17), Govt. Degree College Sam, South Waziristan and the period of his absence w.e.f 22.02.2018 shall be treated as unauthorized absence from duty.
